Learning objectives

The training is based on a highly interactive teaching approach to reinforce learning on both technical issues as well as leadership skills. Through the use of case studies, lectures and exercises, participants will be equipped to understand better:

- The importance of promoting financial inclusion in their home jurisdictions,
- The importance of promoting inclusive insurance for women,
- How sound supervisory principles can be applied in a manner that encourages the development of an inclusive insurance market,
- The importance of innovation for inclusive insurance markets,
- How to promote financial inclusion by encouraging supervisors to be adaptable in their roles to appropriately respond to innovative solutions,
- Prudential and market conduct issues in overseeing inclusive insurance markets.

Also, throughout the week and with the guidance of Toronto Centre's Program Leaders, participants will put into practice Toronto Centre's action planning for dealing with challenges faced at the workplace as well as stakeholder communication concepts in introducing inclusive insurance in their jurisdictions. This will enable them to develop action plans to implement in their home agencies upon return.
